Artist Release Agreement

The Artist identified below ("Artist") seeks to display artwork, performance, music, and/or other materials that he/she has created and submitted for the listing in the CALIFORNIA ARTISTS DIRECTORY. The Directory is located at the National Arts and Disability Center (NADC) web site (the "Directory") operated by The Regents of the University of California on behalf of its Los Angeles Campus. I also grant the NADC the right to use my name, voice, image of physical likeness, biographical material, contact information, and other information, including any details of my disability on the NADC web site.

The NADC does not charge a fee for listing in the CALIFORNIA ARTISTS DIRECTORY. In addition, there is no payment to me, my heirs or assigns for inclusion in the Directory. I agree that the NADC may use the works and the personal information, in any manner or media for the inclusion in the California Directory and online database, to include contact and personal information.

The NADC reserves the right to select this artwork to be displayed on the home page of the NADC web site at <http://nadc.ucla.edu>. The NADC has the right to change an image size if the image does not fit into the Directory and view standards.

The Artist warrants and represents that he or she is the sole legal owner of all right, title and interest in all Artwork, including all related intellectual property interests such as trademarks and the sole and exclusive copyright in all artwork, and has the full right and authority to enter this Agreement and grant the rights granted in this Agreement.

The Artist also warrants and represents that the display of the Artwork in the Directory does not and will not infringe or violate the rights of any other party, including any copyright interests. The Artist shall indemnify, defend and hold The Regents of the University of California harmless from any losses, claims, damages, awards, penalties or injuries incurred, including reasonable attorney's fees, which arise from any claim by any third party of an alleged infringement of copyright or any other property right arising out of the display of the Artwork. The Artist understands that the display of the Artwork in the Directory is subject to the sole discretion of the NADC and any or all of the Artwork may be immediately removed from the Directory at the sole and exclusive discretion of the NADC. The university may discontinue the California Artists Directory at anytime at its sole discretion.

The Artist grants to The Regents of the University of California a nonexclusive, royalty free, perpetual license to display the Artwork in the Directory. This license and permission to display the Artwork in the Directory may be revoked at the sole discretion of the Artist upon written notification to the Directory. The Directory will remove the Artwork from the Directory within a reasonable time after receipt of written notice of revocation of the license.
